to the northeast corner of this claim, corner no. 1; thence,

South 750 feet to the East Side Center; thence,  
South 750 feet to the Southeast Corner; thence,  
West 600 feet to the Southwest Corner; thence,  
North 750 feet to the West Side Center; thence,  
North 750 feet to the Northwest Corner; thence,  
East 600 feet to the Northeast Corner; the point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 50 feet from the location monument in a northerly direction, and 1450 feet in a southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

All claim corners, side centers and location monuments are plastic pipe or wooden posts, at least 4 inches in diameter by 5 feet in length, set 1 foot in the ground and properly marked with metal tags.

The monumentation and marking of the corners was completed by the 10th day of January, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$ 20.75 lode claim filing fee has been paid the County Recorder.
