SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

This Deed of Trust, made this third day of April, 1985, between

Witnesseth: That Trustor IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST, WITH POWER OF SALE, that property in the town of Panaca, Lincoln County, Nevada, described as:

A PORTION OF LOT ONE (1) IN BLOCK SIXTEEN (16) IN THE TOWN OF PANACA, NEVADA, DESCRIBED AS FOLLOWS, TO WIT:

COMMENCING AT A POINT 136 FEET SOUTH OF THE NORTHWEST CORNER OF SAID LOT ONE (1), BLOCK SIXTEEN (16) AND RUNNING; THENCE EAST 100 FEET; THENCE SOUTH 20 FEET; THENCE EAST 164 FEET; THENCE SOUTH 55 FEET; THENCE WEST 264 FEET; THENCE NORTH 75 FEET TO THE TRUE PLACE OF BEGINNING.

TOGETHER WITH the rents, issues and profits thereof, reserving the right to collect and use the same except during continuance of some default hereunder and during nonpayment of such default authorizing Beneficiary to collect and enforce the same by any lawful means in the name of any party herein.

For the Purpose of Securing: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. Payment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$12,500.00 executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be advanced for the account of Trustor or Assignee by Beneficiary with interest thereon.

To Protect the Security of This Deed of Trust, Trustor Agrees: By the execution and delivery of this Deed of Trust and the note secured hereby, that provisions (1) to (16) inclusive of the Deed of Trust recorded in the Book and at the page, or document No. of Official Records in the Office of the county recorder of the county where said property is located, noted below opposite the name of such county, viz.:
