We (or I) claim 1500' linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1480 feet from the location monument in a North direction, and 20 feet in a SOUTH direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
