We (or I) claim 1500' linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1440 feet from the location monument in a North direction, and 20 feet in a SOUTH direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a POST 4' four feet high, inscribed "NW Corner of the HORSE # 5 Claim;" the southwest corner is marked by a 4' four feet high, inscribed "SW Corner of the HORSE # 5 Claim;" the southeast corner is marked by a 4' four feet high, inscribed "SE Corner of the HORSE # 5 Claim;" the northeast corner is marked by a 4' four feet high, inscribed "NE Corner of the HORSE # 5 Claim." There is also a 4' post at the center of each side line.

ALL MARKED ON ALUMINUM TAGS NAILED TO THE POSTS - Posts are Pine and Cedar. The monumentation and marking of the corners was completed by the 28 day of May, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
