CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the HORSE # 12 lode mining claim

on the 28 day of MAY, 1985, situated in the UNKAMED Mining District, LINCOLN County, State of NEVADA, In Section 6-7-1-12, Township 2 N., Range 71E.-70E.

We (or I) claim 1500' linear feet along the course of the mineral-bearing ledge, lode or vein, extending 20 feet from the location monument in a North direction, and 1480 feet in a SOUTH direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a POST 5' tall feet high, inscribed "NW Corner of the HORSE # 12 Claim;" the southwest corner is marked by a 5' tall feet high, inscribed "SW Corner of the HORSE # 12 Claim;" the southeast corner is marked by a 5' tall feet high, inscribed "SE Corner of the HORSE # 12 Claim;" the northeast corner is marked by a 5' tall feet high, inscribed "NE Corner of the HORSE # 12 Claim." There is also a 5' post at the center of each side line.

ALL MARKED ON ALUMINUM TAGS MAILED TO THE POSTS - Posts are Pine and Cedar.

The monumentation and marking of the corners was completed by the 28 day of May, 1985. (must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
