DEED OF TRUST

This Deed of Trust, Made this 28th day of May, 1985, 1985

Between Michael R. Rollins, herein called TRUSTOR,

Don Vincent and Reliable Bail Bonds, herein called TRUSTEE,

and Don Vincent, herein called BENEFICIARY.

WITNESSETH: That Trustor hereby CHANTS to TRUSTEE, IN TRUST, WITH POWER OF SALE, all that property in the County of LINCOLN, Lincoln, State of Nevada, described as:

as per map recorded in Book _____, Page _____ of Maps, Miscellaneous Records

in the office of the County Recorder of Lincoln County.

FOR THE PURPOSE OF SECURING payment to the said Beneficiary, of the monies due to and of all losses, damages, expenditures and liability suffered, sustained, made or incurred by the surety company, hereinbefore called the Surety or Beneficiary (and or monies held set forth and described in a certain indemnity agreement, which agreement is made a part hereof by reference as though fully set forth) on account of, growing out of, or resulting from the execution of a certain bond on behalf of Daryl W. Rollins.

In the matter of State of Nevada vs. Daryl W. Rollins
AND FOR WHICH AMOUNTS and the monies set forth in the said indemnity agreement, the presents are witness.

IT IS AGREED AND CONCLUDED THAT a certificate signed by the Beneficiary at any time hereafter setting forth that the said bond has been declared forfeited or that a loss, damage, expenditures or liability has been sustained by the Surety or Beneficiary on account of the aforesaid Undeclared, the date or dates and amount of amounts of such loss, damage, expenditures and/or liability, that payment has been demanded of the party or parties on whom to hold the other and that such sum was or is about to be collected, and that such loss, damage, expenditures or determinable liability has not been paid to the Plaintiff, shall be conclusive and binding on the Trustee, and shall be the warrant of the Trustee to proceed forthwith to foreclose and to sell upon the security herein, out from the proceeds of sale (after deducting expenses including cost and amount of evidence of title) pay to the Beneficiary the amount so certified, including interest at ten per cent per annum from demand to date of payment and attorney's fees.

IT IS FURTHER AGREED THAT: Upon delivery of and Certificate to Trustee, Beneficiary may declare all sums or obligations accrued hereon due and payable by delivery to Trustee of written declaration of default and demand for sale and of written notice of default and of election to cause to be sold and property, which notice Trustee shall cause to be duly filed for record.

THE UNDERSIGNED TRUSTOR REQUESTS that a copy of any notice of default and of any notice of sale hereunder be mailed to him at his mailing address opposite his signature hereto. Failure to insert such address shall be deemed a waiver of any request hereunder for a copy of such notices.


