July, 1985, and it appearing to the court that all notices  
required by law have been given, and the court being duly advised  
in the premises, now enters its Findings of Fact, Conclusions of  
Law and Order:

FINDINGS OF FACT

That MARIE J. HOFFMAN is a resident of the State of  
Nevada.

That MARIE J. HOFFMAN has Alzheimer's Disease with  
paranoid psychosis and ataxia probably secondary to some  
cerebellar vascular insufficiency and is unable to care and pro-  
vided for herself and to manage her own affairs.

That EILEEN BARNETT, Lincoln County District Attorney

1 and ex officio Public Guardian, has heretofore been appointed by  
2 this court as Temporary Guardian and has filed an official bond  
3 in the amount of Ten Thousand Dollars (\$10,000.00).

4 CONCLUSIONS OF LAW

5 That a guardian, qualified under the laws of the State  
6 of Nevada, should be appointed as the Guardian of the person and  
7 estate of MARIE J. HOFFMAN.

8 ORDER

9 IT IS HEREBY ORDERED that EILEEN BARNETT, Lincoln County  
10 District Attorney and ex officio Public Guardian, be, and she is  
11 hereby, appointed as Guardian of the person and estate of MARIE  
12 J. HOFFMAN, and her official bond, heretofore filed herein in the  
13 sum of Ten Thousand Dollars (\$10,000.00) shall have full force  
14 and effect, and Letters of Guardianship of the person and estate  
15 of MARIE J. HOFFMAN shall issue to EILEEN BARNETT upon her  
16 serving notice upon the heirs at law and next of kin of the ward,  
17 so far as may be determined, to-wit:
