RGREEMENT

STATE OF NEVADA | KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this the discussion of page, 1985, by and between WORLD HYDROCARBON, INC., a Texas Corporation with its principal offices at 10830 N. (2) Deposit to the account of C. C. HARTER, JR. with ENGELHARD CORPORATION 1196 ounces of pure silver as same is mined and milled from said Silverhorn Mine.

It is further agreed between the parties signatory hereto should BFM sell, transfer, or convey that bFM will not sell, transfer, sonvey of hypothesate any portion of its remaining 17.5% undivided interest in and to the SILVERHORN MINE and/or the SILVERHORN JOINT VENTURE, within Mine and/or the silver set deliver to WORLD and HARTER the amounts of pure silver set
