WHEREAS, the Nevada Department of Transportation, pursuant to the provisions contained in N.R.S. 408.527, may relinquish, vacate, and abandon by resolution, any portion of a State highway to cities and counties: and

WHEREAS, the Board of Commissioners of Lincoln County, Nevada, consented by resolution passed and adopted on July 5, 1985, to the Nevada Department of Transportation relinquishing the aforesaid portion of said Road to the County of Lincoln.
