

JOINT TENANCY DEED

THIS INDENTURE made this 6th day of May, A.D. 1983, between Nelson Bleak and Martha Bleak, husband and wife, the parties of the first part, and N. Lorell Bleak and Terry W. Bleak, husband and wife, as joint tenants with right of survivorship, the parties of the second part,

WITNESSETH: That the said parties of the first part for a valuable consideration, the receipt whereof is hereby acknowledged, do by thence presents, GRANT, BARGAIN and SELL unto the said parties of the second part, as Joint Tenants and not as tenants in common, and to the survivor of them and the heirs and assigns of such survivor forever, all the following property situate in the Community known as Ursine, at Eagle Valley, in the County of Lincoln, State of Nevada, and bounded and described as follows, to-wit:

Beginning at the Southwest corner of Lot numbered Ten (10) as shown on the Map of the Eagle Valley Settlement, Lincoln County, Nevada, surveyed and platted by Frank Walker, County Surveyor, Situate within the North half of the Southeast quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 35, T.2 N., R. 69 E., M.D.B. & M., and running thence North-easterly along the Westerly boundary line of said lot 10 a distance of 130.3 feet, to the South west corner of Harold Hammonds plot, thence running at right angles southeasterly along the southern line of Harold Hammonds plat a distance of 106 feet; thence at right angles southwest a distance of 130.3 feet, more or less to the Southerly line of said lot 10; thence Northwesterly along the southerly line of said lot 10 a distance of 105 feet to the true point of beginning.

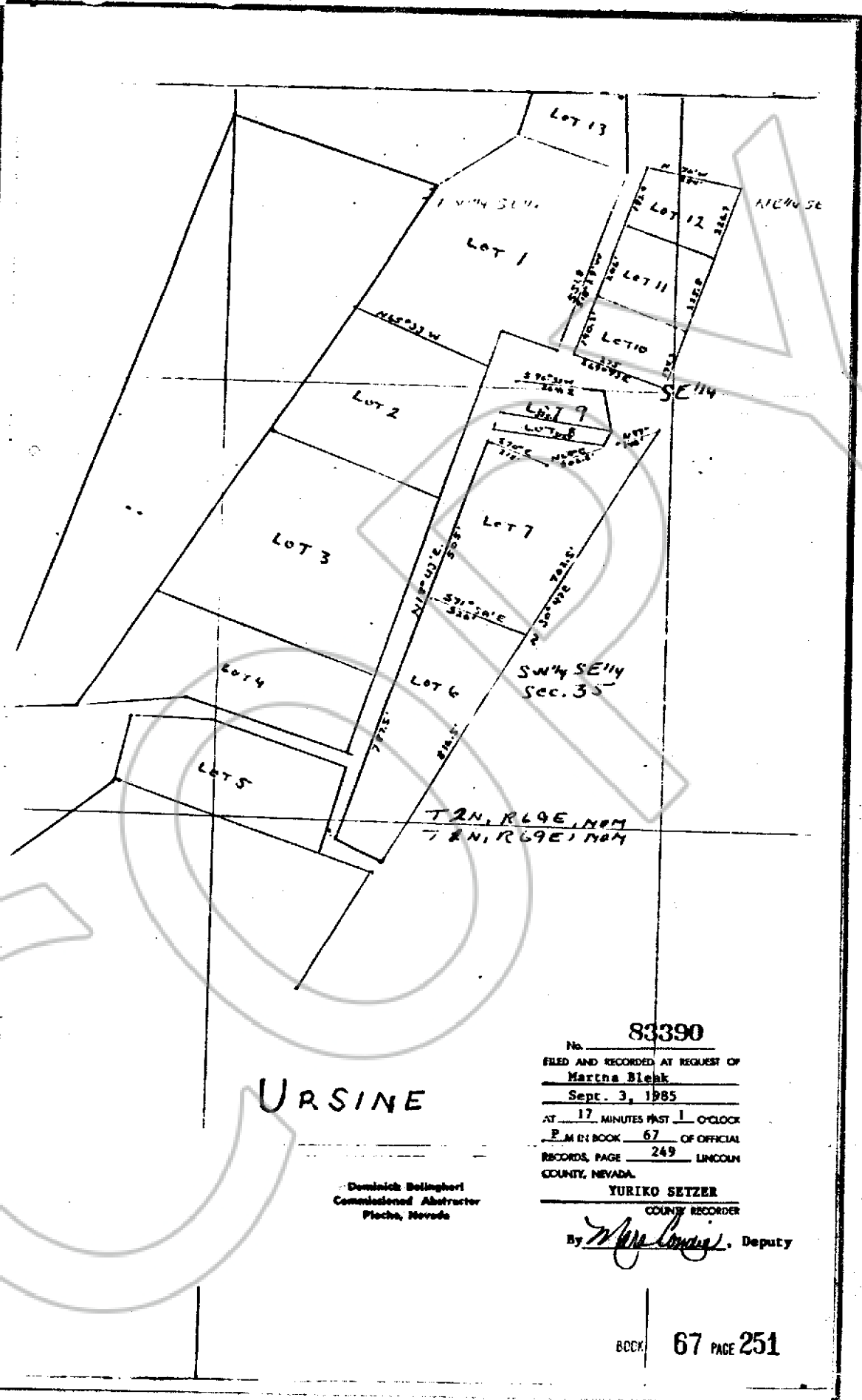
