CERTIFICATE OF LOCATION OF LODE MINING CLAIM

(Prepared by the Nevada Bureau of Mines and Geology, and Approved by Attorney General of Nevada, August 1971)

The undersigned hereby certifies Silver Pipe No 13 Lode Mining Claim in Section 27, Township 2N, Range 6E in the unknown Mining District, in Lincoln County, in the State of Nevada, on the 28th day of Sept., 1985.

The claim is 500 feet long and 600 feet wide, and 1480 feet is claimed in a North direction and 10 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Scribed Markings.

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 4" diameter Plastic Pipe - 5' in length with 1 foot bend
