27 service or by certified mail, identifying his claim and
28 describing the property claimed to every person whose right to
29 succeed to the decedent's property is equal or superior to that
30 of the affiant; and

31 That at least ten (10) days have elapsed since the
32 notice was served or mailed; That the affiant is personally

1 entitled to full payment or delivery of the property claimed or
2 is entitled to payment or delivery on behalf of and with the
3 written authority of all other successors who have an interest in
4 the property.

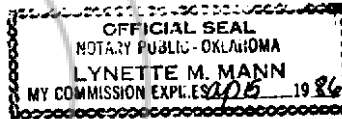
5 That he has the right, pursuant to the provisions of
