CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the AA #4 Lode Mining Claim in SEk Sec. 5; NEk Sec. 8, Township 3S, Range 67E in the Chief Mining District, in Lincoln County, in the State of Nevada, on the 21 day of September, 1985.

The claim is 1500 feet long and 600 feet wide, and 25 feet is claimed in a north direction and 1475 feet in a south direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the north to the south. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribed metal tag.

(Describe method of marking, such as "scribing the wood") The description of each corner is as follows (describe the corner(s), such as "4 x 4 wooden post"),

- Corner No. 1 is a 3" dia. x 5' metal post
Corner No. 2 is a 3" dia. x 5' metal post
Corner No. 3 is a 3" dia. x 5' metal post
Corner No. 4 is a 4" x 4" x 4 1/2' wooden post
Corner No. 5 is a 4" x 4" x 4 1/2' wooden post
Corner No. 6 is a 3" dia. x 5' metal post

The monumentation and marking of the corners was completed by the 17 day of October, 1985. (Must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
