CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the AA #48 Lode Mining Claim in NE 1/4 Sec. 18, Township 3S, Range 67E in the Chief Mining District, in Lincoln County, in the State of Nevada, on the 22 day of September, 1985.

The claim is 800 feet long and 600 feet wide, and 100 feet is claimed in a west direction and 700 feet in a east direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the east to the west. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribed metal tag.

- Corner No. 1 is a 3" dia. x 5' metal post
Corner No. 2 is a 3" dia. x 5' metal post

Corner No. 4 is a 3" dia. x 5' metal post
Corner No. 5 is a 3" dia. x 5' metal post
Corner No. 6 is a 3" dia. x 5' metal post

The monumentation and marking of the corners was completed by the 27 day of October, 1985. (Must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
