

# Certificate of Location of Lode Mining Claim

The general course of the lode deposit and premises is from the north to the south

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by a scribed metal tag

The monumentation and marking of the corners was completed by the 25 day of October, 19 85.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
