## CERTIFICATE OF LOCATION OF LODE MINING GLAIM

To all Whom It May Concern:

The undersigned hereby certifies that he has located the Cedar 8 lode mining claim in Section 23.T. 5 S., R. 64 E., in the Delamar Mining District, Lincoln County, Nevada, on the 14th day of September, 1985.
