SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

This Deed of Trust, made this twenty-third day of October 1985, between

Witnesseth: That TRUSTOR IRREVOCABLY CHANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST, WITH POWER OF SALE, that property in Lincoln County, Nevada, described as:

PARCEL I:

Lots twenty-four (24) and twenty-five (25) in block "B" of the James H. Gottfredson Addition to the city of Caliente.

EXCEPTING THEREFROM the Easterly Six (6) feet of Lot Twenty-five (25).

PARCEL II:

Lots Eight (8), Nine (9), Ten (10), and Eleven (11) in Block Thirteen (13) in the City of Caliente.

This Deed of Trust is being recorded second and junior to the existing Deed of Trust.

TOGETHER WITH the rents, issues and profits thereof, reserving the right to collect and use the same except during continuance of some default hereunder and during continuance of such default authorizing Beneficiary to collect and enforce the same by any lawful means in the name of any party hereto.

For the Purpose of Securing: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. Payment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$6,110.68 executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be advanced for the account of Trustor or Assignee by Beneficiary with interest thereon.
