CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 10 lode mining claim was located

the mining laws of the United States of America and the State of Nevada, 1,500 feet  
along the vein thereof, together with 300 feet on each side of the center of said  
vein. The general course of said vein being Northeasterly and Southwesterly  
with 1,490 feet claimed in a Northeasterly direction and 10 feet in a  
Southwesterly direction from the Discovery Monument, at which the Notice of  
Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln,  
State of Nevada and is located in all or in part of the following 1/4 Section(s):

8,947 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial  
4 inch diameter x 4 1/2 foot long plastic post monuments firmly set in the ground  
with an aluminum tag marked with the appropriate monument designation. The description
