CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 19 lode mining claim was located

 vein. The general course of said vein being Southwesterly and Northeasterly
 with 1,490 feet claimed in a Southwesterly direction and 10 feet in a
Northeasterly direction from the Discovery Monument, at which the Notice of
 Location is posted.
