## CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 29 lode mining claim was located

on the 14th day of November, 1985. Said locator claims under and by virtue of  
 the mining laws of the United States of America and the State of Nevada, 1,500 feet  
 along the vein thereof, together with 300 feet on each side of the center of said  
 vein. The general course of said vein being Southwesterly and Northeasterly  
 with 1,490 feet claimed in a Southwesterly direction and 10 feet in a  
Northeasterly direction from the Discovery Monument, at which the Notice of  
 Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln,  
 State of Nevada and is located in all or in part of the following 1/4 Section(s):

SW 1/4 of Section 27, Township 9 S., Range 65 E., M.D.B. & M.

SE 1/4 of Section 28, Township 9 S., Range 65 E., M.D.B. & M.

NE 1/4 of Section 33, Township 9 S., Range 65 E., M.D.B. & M.

The above described township and range is unsurveyed.

To tie this claim to the Public Survey, begin at the Southeast Corner of  
 Section 35, Township 8 S., Range 65 E., Mount Diablo Base and Meridian,  
 thence South, approximately 25,470 feet and West, approximately  
11,936 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial  
4 inch diameter x 4 1/2 foot long plastic post monuments firmly set in the ground  
 with an aluminum tag marked with the appropriate monument designation. The description

thence, S.65°E., 600 feet to the Northeast Corner (Cor. No. 2),

thence, N.65°W., 600 feet to the Southwest Corner (Cor. No. 5),

thence, N.25°E., 750 feet to the West Side Center (Cor. No. 6),

thence, N.25°E., 750 feet to the Northwest Corner (Cor. No. 1),
