CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 43 lode mining claim was located by:

The general course of said vein being Southwesterly and Northeasterly with 1,490 feet claimed in a Southwesterly direction and 10 feet in a Northeasterly direction from the Discovery Monument, at which the Notice of Location is posted.
