CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 52 lode mining claim was located

 vein. The general course of said vein being Northeasterly and Southwesterly
 with 1,490 feet claimed in a Northeasterly direction and 10 feet in a
Southwesterly direction from the Discovery Monument, at which the Notice of
 Location is posted.
