CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the VAN No. 55 lode mining claim was located by:

Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Southwesterly and Northeasterly with 1,490 feet claimed in a Southwesterly direction and 10 feet in a Northeasterly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln, State of Nevada and is located in all or in part of the following 1/4 Section(s):

SW 1/4 of Section 33, Township 9 S., Range 65 E., M.D.B. & M.

SE 1/4 of Section 33, Township 9 S., Range 65 E., M.D.B. & M.

NW 1/4 of Section 4, Township 10 S., Range 65 E., M.D.B. & M.

NE 1/4 of Section 4, Township 10 S., Range 65 E., M.D.B. & M.

The above described township and range is unsurveyed.

To tie this claim to the Public Survey, begin at the Southeast Corner of Section 35, Township 8 S., Range 65 E., Mount Diablo Base and Meridian, thence South, approximately 31,108 feet and West, approximately 14,472 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial 4 inch diameter x 4 1/2 foot long plastic post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, S.65°E., 600 feet to the Northeast Corner (Cor. No. 2),

thence, S.25°W., 750 feet to the East Side Center (Cor. No. 3),

thence, S.25°W., 750 feet to the Southeast Corner (Cor. No. 4),

thence, N.65°W., 600 feet to the Southwest Corner (Cor. No. 5),

thence, N.25°E., 750 feet to the West Side Center (Cor. No. 6),

thence, N.25°E., 750 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.
