

# NOTICE OF LOCATION OF PLACER CLAIM

NOTICE IS HEREBY GIVEN, that the undersigned located and now claim the following described placer mining ground, containing 160 acres, more or less, situated in UNKNOWN Mining District, LINCOLN County, State of NEVADA and being more particularly described and marked on the ground as follows: The claim encompasses the S.E. 1/4, Section 13, Township 1 South, Range 66 East (Unsurveyed), Mtn Diablo B & M, and consists of 160 acres, more or less.

The boundaries of the claim have been distinctly marked on the ground by the placement at each corner thereof of a monument consisting of a post at least four inches square by four feet six inches in length, set one foot in the ground.

Corner No. 1 and Discovery Monument of the claim is 7920 feet South and 2640 feet West of the Northwest Corner of Section 7, Township 1 South, Range 67 East, Mount Diablo Meridian, Lincoln County, Nevada.

The boundaries of the claim may be described as follows: Beginning at the Northwest Corner of the Claim, which is marked Corner No. 1 of the CHAUX No. 7 Claim; Thence East 2640 feet to the Northeast Corner of the Claim, which is marked Corner No. 2 of the CHAUX No. 7 Claim; Thence South 2640 feet to the Southeast Corner of the Claim, which is marked Corner No. 3 of the CHAUX No. 7 Claim; Thence West 2640 feet to the Southwest Corner of the Claim, which is marked Corner No. 4 of the CHAUX No. 7 Claim; Thence North 2640 feet to Corner No. 1, the place of beginning.

This Claim adjoins the CHAUX No.          Claim on the East; the CHAUX No.          Claim on the South; the CHAUX No.          Claim on the West; and the CHAUX No. 5 Claim on the North.

This claim is located upon a placer deposit of valuable minerals.
