CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the MER NO. 12 lode mining claim was located by:

Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Easterly and Westerly with 1,490 feet claimed in an Easterly direction and 10 feet in a Westerly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln, State of Nevada and is located in all or in part of the following 1/4 Section(s):
