## CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the MER NO. 23 lode mining claim was located by:

on the 14<sup>th</sup> day of February, 1986. Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Easterly and Westerly with 1,490 feet claimed in an Easterly direction and 10 feet in a Westerly direction from the Discovery Monument, at which the Notice of Location is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln, State of Nevada and is located in all or in part of the following 1/4 Section(s):

SW 1/4 of Section 14, Township 6 S., Range 67 E., M.D.B. & M.

SE 1/4 of Section 15, Township 6 S., Range 67 E., M.D.B. & M.

NE 1/4 of Section 22, Township 6 S., Range 67 E., M.D.B. & M.

NW 1/4 of Section 23, Township 6 S., Range 67 E., M.D.B. & M.

The above described township and range is unsurveyed.

To tie this claim to the Public Survey, begin at the Northeast Corner of Section 1, Township 6 S., Range 67 E., Mount Diablo Base and Meridian, thence South, approximately 15,772 feet and West, approximately 11,546 feet to the Northwest corner (Cor. No. 1) of this claim.

The exterior boundaries of this claim are clearly marked by substantial 4 inch diameter x 4 1/2 foot long plastic post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, East, 750 feet to the North Side Center (Cor. No. 2),

thence, East, 750 feet to the Northeast Corner (Cor. No. 3),

thence, South, 600 feet to the Southeast Corner (Cor. No. 4),

thence, West, 750 feet to the South Side Center (Cor. No. 5),

thence, West, 750 feet to the Southwest Corner (Cor. No. 6),

thence, North, 600 feet to the Northwest Corner (Cor. No. 1), the point and place of beginning.
