SUBORDINATION AGREEMENT

For value received, I, or we, Southern Nevada Baptist Association, a Nevada Corporation, do hereby subordinate the right to acquire by way of reverter under the terms and conditions as set forth in the Warranty Deed from Southern Nevada Baptist Association, a Nevada Corporation, to Berean Baptist Church of Pioche, a Nevada Corporation, dated January 15, 1986, and recorded in Book 69, Page 401, State of Nevada, County of Lincoln, the following described real property situated in Lincoln County, Nevada:

Lots 3 and 4 in Block "B" of the West End Addition to the City of Caliente, Lincoln County, Nevada.

Such right of reverter is hereby subordinated in favor of the Deed of Trust, dated March 18, 1986, between Berean Baptist Church, Trustor, and Stewart Title of Nevada, a Nevada Corporation, Trustee, and Home Mission Board of the Southern Baptist Convention, a religious non-profit corporation of the County of Fulton and State of Georgia, Beneficiary, and recorded in Book 70, Page 155, State of Nevada, County of LINCOLN, so that, in the event of the acquisition of said property by Southern Nevada Baptist Association by way of reverter or in any other manner, said property shall be held by it subject to the terms and conditions of this mortgage; and if such property shall ever be sold at foreclosure upon default in the terms of this mortgage, such sale and the conveyance of said property in compliance therewith shall be made free and clear of the legal operation and effect of said reverter clause.
