



Amendment of Note and Security Instrument

- (a) The principal sum shall be \$ 180,000.00
(b) Interest shall be charged at the rate of Prime + 2.00% per cent ( 11.00 %) per annum from April 10, 1986 until paid;
(c) Said principal and interest shall be payable as follows: Interest will be due quarterly from date of note and principal will be due on or before 1 year.

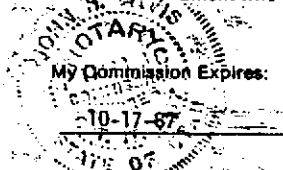
