

QUITCLAIM DEED

Beginning at a point (1) which is the Northwest Corner of this parcel from which the Northwest Corner of said Section 8 bears N. 44°26'55" W a distance of 1,904.22 feet more or less; thence N. 89°48'16" E a distance of 977.50 feet more or less, to the NE Corner (2); thence S 0°17'13" W a distance of 60.00 feet more or less, to the SE Corner (3); thence S 89°48'16" W a distance of 727.50 feet more or less to a point (4); thence S. 0°17'13" W a distance of 40.00 feet, more or less, to a point (5); thence S. 89°48'16" W a distance of 250.00 feet, more or less, to the SW Corner (6); thence N 0°17'13" E a distance of 100.00 feet more or less, to the point of beginning. 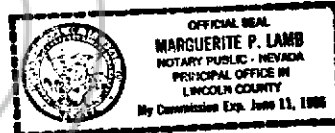
