

ORDER SETTLING FIRST AND FINAL ACCOUNT AND REPORT OF EXECUTRIX AND GUARDIAN, AND ALLOWING COMMISSIONS, FEES AND COSTS; AND DECREE OF FINAL DISTRIBUTION OF ESTATE AND GUARDIANSHIP ESTATE

Johnne Jackson, as Executrix of the Estate of Howard Jackson, deceased, and as Guardian of the person and estate of Rhonda Jackson, a former minor, having filed with the Clerk of this Court on April 1, 1986, a verified First and Final Account and Report of Executrix and Guardian, and Petition For Fees and Costs, For Final Distribution and For Final Discharge of the Executrix and Testamentary Guardian, said account and petition having come regularly to be heard on the 23rd day of April, 1986,

and no person appearing to contest said account and petition, the Court having considered the same and examined the papers on file in this matter finds that due and legal notice of the time and place of such hearing has been given in the manner required by law; that notice of disallowance of the creditor's claim of Tess C. Jackson having been given by the Executrix on April 23, 1980, and no suit having been brought against the executrix as required by NRS 147.130(1), said claim is forever barred; that proper notice of this hearing has been given to Tess C. Jackson and to Albert E. Cartlidge, C.P.A.; that Rhonda Jackson, now known as Rhonda Jackson Coalwell, became eighteen years old on July 24, 1983, and that the guardianship of Rhonda Jackson is terminated pursuant to NRS 159.191(1); that all allegations in said account and petition are true, and that after allowance and payment of executrix's and guardian's commissions, accounting and attorneys' fees and costs of administration as hereinafter allowed, the guardianship estate will be in proper condition to be finally distributed to Rhonda Jackson Coalwell, and the estate of Howard Jackson will be in proper condition to be finally settled and distributed to the beneficiaries hereinafter named.

The Court therefore settles said account and makes its Orders and Decrees as follows:

IT IS ORDERED, ADJUDGED AND DECREED that the First and Final Account and Report of the Executrix be, and it is, hereby settled, allowed and approved, and all actions taken by the Executrix in connection with the administration of the estate are hereby ratified, and approved;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the 2 Executrix is hereby authorized and directed to pay to herself the sum of \$509.44 representing the balance of \$1,473.50 allowed as her commission for services rendered in administering the estate; and that the reduction of said \$1,473.50 commission by the sum of \$964.06 shall constitute full reimbursement to the estate of the account receivable due from JoAnne Jackson.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Executrix is hereby authorized and directed to pay those administrative expenses for January, 1986 totalling \$341.98 as detailed in Exhibit 16 of the First and Final Account.
