AMENDED LOCATION CERTIFICATE

KNOW ALL MEN BY THESE PRESENTS:

1. That the undersigned, Wesley Koyen and Eva Koyen, in preparing this Certificate of Amendment of Location are husband and wife.
2. The name of the claim amended by this Certificate is Emerald originally located on the 5th day of April, 19 71, the original Certificate of Location being recorded in the Office of the County Recorder of Lincoln ~~County~~ Nevada, on the 28th day of June, 19 71, in Book 1 at Page 559.
3. This Certificate is prepared, posted and recorded as an amendment of the original location (as heretofore amended) and to correct any error, irregularity, omission or incompleteness of said original location (and the amendment thereof) and without waiver, abandonment or release of any rights acquired or held under said initial or original location (or the prior amendment thereof) and is made by the locator and discoverer.
4. Discovery work as required by law and is further conformity with the laws of the State of Nevada as reperformed on this claim.

5. The description of this claim, its boundaries and its situation as amended are as follows:

(a) Extent of Claim: From the point of discovery at which a copy of this Certificate is posted on a substantial monument extending at least $4\frac{1}{2}$ feet in height above the ground, in width, 300 feet in a N. 43°03'08" W. direction, and 300 feet in a S. 43°03'08" E. direction, and in length, along the vein 750 feet in a N. 46°56'52" E. direction, and 750 feet in a S. 46°56'52" W. direction, comprising in all 1,500 feet in length and 600 feet in width.

(b) Description: This claim is located in W 1 Section 24, Township 2, North, Range 54 East, Mount Diablo Base and Meridian, Lincoln and Nye County(ies) Nevada. The exterior boundaries of this claim are distinctly marked by posts or monuments at each corner and side center and its boundaries can be readily traced, viz: beginning at Corner No. 1 of said claim; thence N. 46°56'52" E., 750 feet to Corner No. 2 of said claim; thence N. 46°56'52" E., 750 feet to Corner No. 3 of said claim; thence S. 43°03'08" E., 600 feet to Corner No. 4 of said claim; thence S. 46°56'52" W., 750 feet to Corner No. 5 of said claim; thence S. 46°56'52" W., 750 feet to Corner No. 6 of said claim; thence N. 43°03'08" W., 600 feet to Corner No. 1 of said claim the point of beginning, containing 20.66 acres.

(c) Tie: Corner NO. 1 of this claim bears S. 55°28'43" E. at 33,452.18 feet from the Northwest corner of Section 6, Township 2 North, Range 54 East, Mount Diablo Base and Meridian.
