

# Last Will and Testament

PATRICIA BLANCHARD

I, PATRICIA BLANCHARD, formerly PATRICIA ROBINSON, a resident of and domiciled in Pioche, Nevada, do hereby make, publish, and declare this to be my Last Will and Testament, revoking all former Wills by me at any time made.

I

I declare that I am a widow. I have three children living, namely, PETER ANDREW ROBINSON, who was born November 7, 1949, PATRICIA ANN ALEXANDER, who was born September 4, 1948, and MICHAEL PHILLIP ROBINSON, who was born December 25, 1946.

II

I order and direct that all of my just debts and funeral expenses be paid as soon as conveniently it may be done after my decease by my Executor hereinafter named.

III

I hereby nominate and appoint CHARLES W. DEANER as Executor of this, my Last Will and Testament, to serve without bond; in the event he shall predecease me, or for any reason fail to so serve, I then nominate and appoint J. DOUGLAS DEANER as Substitute Executor, to serve without bond.

VI

I give, devise, and bequeath to my son PETER ANDREW ROBINSON my Steinway Upright Piano, tools, equipment, machinery,

accessories located in the equipment shop on my Pioche, Nevada, property, and my John Deere tractor and accessories.

VII

I give, devise, and bequeath to my son MICHAEL PHILLIP ROBINSON all my string instruments.

VIII

I give, devise, and bequeath to my daughter, PATRICIA, all my jewelry, silver, dishes, China, and all motor vehicles owned by me at the time of my demise.

IX

I give, devise, and bequeath all the rest, residue, and remainder of my property, real, personal and mixed, owned by me at my death, 1/3 to PETER ANDREW ROBINSON, 1/3 to MICHAEL PHILLIP ROBINSON, and 1/3 to PATRICIA ANN ALEXANDER, if they survive me. If PETER ANDREW ROBINSON or PATRICIA ANN ALEXANDER shall predecease me, then their share shall go to their issue share and share alike. If my son MICHAEL does not survive me, then his share is to go to his son JEREMY ROBINSON, who presently resides at Pas Christen, Mississippi.

X

I have intentionally omitted to provide for, and specifically will and direct that under no circumstances shall any part, share or interest in, to or of my property, estate or effects, go to or be taken by any of the next of kin or heirs at law of mine nor expressly mentioned in this Will by name as devisee, legatee or other donee or beneficiary. Should any person or persons, whether named in this Will or not, contest

this Will or seek to take any part or parcel of my property, estate or effects, contrary to the provisions hereof, then, and in that event, I do hereby give, devise, and bequeath to each such person or persons the sum of One Dollar (\$1.00) in lieu and bar of any other share or interest in my property, estate or effects.

XI

I hereby empower my Executor to sell, at public or private sale, and convey any part of my estate, real and personal, deemed advisable by my Executor, the time, terms, and conditions of sale to be determined by said Executor.

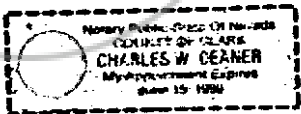
