SUMMARY REPORT

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the VI # 1-17, 21-30, 36-38, 41-43, 45-48, 51-57, 60-66, 76, 78, 80, 82-86, 94-119, 124-130, 132-133, 135-145, 151, 153, 155, 157, 159, 161, 163, 200-220, and 221-228 and the Peak # 1-10 lode mining claims, a contiguous group of 151 claims in the Viola mining district.

The work was conducted on VI Nos. 229-243 claims, which are contiguous with the rest of the claim block, for the benefit of the entire group of claims. The work was a continuation of and a follow up to work conducted prior to the current assessment year.

Geologic mapping and geochemical sampling were conducted to further evaluate the prior discovery of valuable mineral deposits and to assist in planning additional exploration and development work. The geochemical sampling was concentrated along extensions of previously discovered vein structures. Also massive silicification zones along a newly discovered structure were sampled and studied. This sampling revealed the presence of anomalous silver and indicator trace elements (arsenic, antimony, mercury) with these structures. Earlier reports are updated being with the results of this work.

The work on the property was performed by David J. Langston, a geologist with eight years experience and a M.S. Degree in geology from the Colorado School of Mines. The work was performed during the periods February 24-March 4, April 12-24, and July 10-11, 1986. The cost of the work was in excess of \$15,100 and was paid for by Canyon Resources Corporation.
