LAST WILL AND TESTAMENT

I, WINIFRED L. GILLINS, now residing in Pioche, County of Lincoln, State of Nevada, do hereby make, publish and declare this to be my Last Will and Testament, and revoke all former wills and codicils made by me.

FIRST: I declare that I am a married woman.

SECOND: I give, devise and bequeath all of my estate and , property of every kind and nature, wherever situated, or which I may own or have any interest in at the time of my death, or over which I have any power of appointment or other disposition, to my husband, ELDEN T. GILLINS, of Pioche, Nevada.

THIRD: If my husband ELDEN T. GILLINS should not survive me, I give, devise and bequeath all of my real property that I died possessed of to JAMES GILLINS, ELDON WALLACE, and HENRY MUIR GILLINS, share and share alike. The remainder of my estate to FRANCES MAGRUM, MARVIN C. HINDS, KATHRYN ROBERTS, JULIA BLANKENSTIEN, and LINDA KIRKPATRICK.

FOURTH: I nominate and appoint my said husband, ELDEN T. GILLINS, as Executor of this my Last Will and Testament. I request that no bond be required of my Executor. In the event my husband, ELDEN T. 3 FIFTH: If any person claiming to be, or who is or may be my
4 heir at law, whether named herein or not, including but not
5 limited shall contest this Will or establish any rights in or
6 to my estate other than those expressly herein provided, I give
7 such person the sum of One and no/100 Dollars (\$1.00) and no
8 more, in lieu of any provisions which I have made or might have
9 made herein for such person, it being my intention to provide
10 herein for the persons named in Paragraphs SECOND and THIRD, and
11 no others.

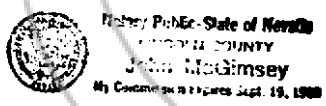
