NOTICE OF MECHANIC'S LIEN

Notice is here given EMKO CORPORATION (hereinafter referred to as "Claimant") of Salt Lake City, Utah claims a lien pursuant to Nev. Rev. Stat. § 108.221 et seq. (1986) upon the improvement and property described hereinafter. Claimant's lien is based upon the following:

1. The Claimant provided labor and/or materials on and in connection with the improvement of a certain Right-of-way located in Clark and Lincoln Counties, Nevada, such Right-of-way granted for the purpose of installing approximately 146 miles of 24 fiber armored fiber optic cable beginning at the East Las Vegas Regeneration Station in Section 10, Township 18 South, Range 63 East, Clark County and continuing through Lincoln County to the Nevada-Utah border, the entire route of which is more particularly described as follows:

Mountain to East Las Vegas," executed on September 2, 1986 by Claimant and Williams Telecommunications Company and by the terms and conditions of which Claimant agreed to install approximately 276.5 miles of 24 fiber armored fiber optic cable in consideration of payment to Claimant in accordance with the terms of the Contract. Claimant furnished the first labor and/or materials on September 4, 1986 and furnished the last labor and/or materials on September 22, 1987.
