

Last Will and Testament of

FIRST: I hereby revoke any and all Wills, Codicils, or testamentary dispositions at any time heretofore made.

SECOND: I hereby designate and appoint my husband, ROBERT CASSISTA, as executor of this my Last Will and Testament, to serve without bond. However, in the event that my husband should be unable or unwilling to serve as such, for any reason, then and in that event, I do designate and appoint my daughter-in-law, SHARON CASSISTA, as executrix of this my Last Will and Testament, to serve without bond.

THIRD: I hereby request that my executor hereinabove named pay all my just debts and funeral expenses as soon after my death as can conveniently be done.

FOURTH: I give, devise and bequeath all the rest, residue and remainder of my property and estate, both real and personal, of every nature and wherever situated, which I may own or be seized of at the time of my death, or to which I may be entitled, to my beloved husband, ROBERT J. CASSISTA.

FIFTH: In the event that my husband, ROBERT J. CASSISTA, should predecease me, or die simultaneously with me, or approximately so, as the result of the same common accident or calamity, or under any circumstances causing doubt as to which of us survived the other, or in such close proximity that in the interval which may occur between our deaths he is physically incapacitated or unable to make a new Will, then and in that event only, I do give, devise and bequeath my property

SIXTH: I hereby declare that I have no other children than those above named, and I have intentionally and with full knowledge omitted to provide for any persons whomsoever claiming to be or who may be lawfully determined to be my heirs-at-law, except as mentioned in this will, and I hereby generally and specifically disinherit any such other persons.

SEVENTH: I further declare that should any person named in this my Last Will and Testament, or their heirs or successors, either directly or indirectly object to or contest the probate of the same or the distribution or disposal of my estate as provided, or in any way hinder the carrying out of the Will and the spirit of any or all terms thereof, then, and in that event, I hereby revoke any and all bequests or devises made herein to such legatees or devisees and I direct that such legatees or devisees take nothing by this Last Will and Testament, and that the portion of the estate which would have gone to such contesting legatee or devisee shall become part of the residue and remainder and distributable to the other legatees and devisees.

EIGHTH: I direct that my attorney WILLIAM E. SAFFE of Pioche, Nevada shall be retained as the attorney in the administration of said estate.

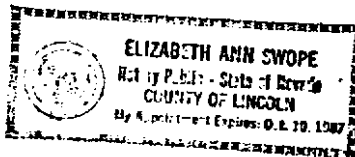
