 7 together with costs of suit incurred herein. In accordance with

9 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that plaintiff  
 10 THE CATAMORE COMPANY, INC. recover from defendants AREKAT  
 11 JEWELERS, HISHAM AREKAT, and ZUMEIRAH AREKAT, jointly and  
 12 severally, the sum of \$523,631.60, plus its costs incurred  
 13 herein.
