THIS IS TO CERTIFY that the ALTA No. 30 lode mining claim was relocated by:

Said locator claims under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,490 feet along the vein thereof, together with 295 feet on each side of the center of said vein. The general course of said vein being Southerly and Northerly with 1,480 feet claimed in a Southerly direction and 10 feet in a Northerly direction from the Discovery Monument, at which the Notice of Relocation is posted.

Said lode claim is situated in the Unknown Mining District, County of Lincoln, State of Nevada and is located in all or in part of the following 1/4 Section(s):

The exterior boundaries of this claim are clearly marked by substantial 4 inch diameter x 4 1/2 foot long post monuments firmly set in the ground with an aluminum tag marked with the appropriate monument designation. The description of such claim is:
