

If any serion kibbs to july any tao neglects or refuses to by the same after demand, the amount (including any inter-sat, additional amount, addition text, or assessable penetry, legether with any costs that may accrue in addition theysto) shall be a hin in favor of the United States upon all property and regrits to property, whither real or personal, belonging to such person.
