Twenty Five Thousand Dollars (\$25,000.00); and that RONNIE LEE

HERRINGTON, KENNETH HERRINGTON, THELMA CAREY, BEVERLY HONING,
VIVIAN CARVER and ALECK T. KAHN are the surviving heirs of the

2 been regularly given as by Statute required.

3 IT IS HEREBY FURTHER ORDERED that GARY D. FAIRMAN, a
4 Professional Corporation, as attorney herein, be awarded the sum
5 of \$ 357.10 as and for his services rendered herein,
6 together with the sum of \$ 125.10 as reimbursement for
7 costs advanced herein.

8 IT IS HEREBY FURTHER ORDERED that after the payment of
9 all costs of administration herein, the rest, residue and
10 remainder of the estate be, and the same is hereby, distributed
11 as follows: the share of MRS. RALPH HERRINGTON, also known as
12 RUBY HERRINGTON, to RALPH MARSHALL HERRINGTON, RONNIE LEE
13 HERRINGTON, and RICHARD HERRINGTON; and the balance of the estate
14 to KENNETH HERRINGTON, THELMA CAREY, BEVERLY HONING, VIVIAN
15 CARVER, and ALECK T. KAHN in equal shares, the surviving heirs of
16 said Decedent. Said estate is more particularly described as
17 follows:
