## Tast Will and Testament

BALDWIN, my entire estate, real or personal of what-soever character and wherever situated, which I now own or am entitled to at the time of my death, provided she survives me and does not die with me in or as a result of a common accident or disaster.

FOURTH: If we both die in or as a result of a common accident or disaster, we give, devise and bequeath our entire estate, real or personal, of whatsoever character and wherever situated to MARIE H. FITZGERALD, mother of Testator LINNEA G. BALDWIN and mother-in-law of Testator, SHERMAN L. BALDWIN, to be here absolutely.

FIFTH: The survivor of us gives all of his or her estate which he or she may own or be entitled to at death in the same manner as set out in the Fourth Paragraph herein.

SEVENTH: We give to our said Executor full power to rent, lease, sell and convey any and all of our property and we expressly authorize our said Executor to make, execute, and deliver good and sufficient rental contracts, leases, deeds of conveyance or any other instruments of writing necessary to effectually carry out the terms of this our Last Will and Testament, and necessary to transfer the title to any and all of our property, real, personal, or mixed without let or hindrance on the part of any person or persons.

EIGHTH: We hereby declare that we have intentionally made no provisions for any person or persons who otherwise would be our heirs and we hereby give and bequeath to any person who might contest this Will the sum of One (\$1.00) Dollar only, in lieu of any other share or interest in our estate either under this Will or through intestate succession.
