# CERTIFICATE OF LOCATION

## LODE-QUARTZ

THIS IS TO CERTIFY that the APACHE # 63 lode mining claim

The monumentation and marking of the corners was completed by the 1<sup>st</sup> day of August, 1987 (must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
