We (or) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or

each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a Cedar 5' feet high, inscribed "NW Corner
of the APACHE # 97 Claim;" the southwest corner is marked by a Cedar 5' feet
high, inscribed "SW Corner of the APACHE # 97 Claim;" the southeast corner is marked by
