The general course of the lode deposit and premises is from the Northeast to the Southwest.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribed tag-on-4" PVC Pipe - Five foot in length, set 1 foot in the ground.
