This Indenture made the 31st day of August one thousand nine hundred and eighty-seven

Between

Donald E. Jung and Kathryn Jung, husband and wife, of Austin, Lander County, Nevada

the parties of the second part,

Witnesseth: That the said parties of the first part, in consideration of the sum of Forty thousand and no/100 dollars,

lawful money of the United States of America to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, and sell unto the said parties of the second part, in joint tenancy and to the survivor of them, and to the heirs and assigns of such survivor forever,

all their right, title and interest in and to certain lot -- piece -- or parcel -- of land situate in the town of Panaca County of Lincoln State of Nevada and bounded and described as follows, to wit:

The West one-half (1/2) of Lot Numbered Two (2) in Block Numbered Fourteen (14), and all of Lot Numbered One (1) in Block Numbered Fourteen (14) as the same is platted and described on the official plat of said town now on file and of record in the office of the County Recorder of Lincoln County, Nevada, and to which said plat, and the records thereof, reference is hereby made for a more full and complete description of said property.

Together with the tenements, hereditaments, and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues, and profits thereof.

To Have and to Hold the said premises, together with the appurtenances, unto the said parties of the second part, as joint tenants, and not as tenants in common, with right of survivorship, and to the heirs and assigns of such survivor forever.
