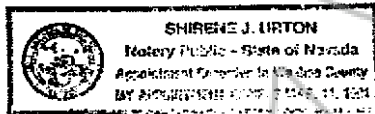

SUMMARY REPORT

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the VI # 1-17, 21-30, 36-38, 41-43, 45-48, 51-57, 60-66, 76, 78, 80, 82-86, 94-119, 124-130, 132-133, 135-145, 151, 153, 155, 157, 159, 161, 163, 200-220, 221-228, and 229-242 and the Peak # 1-10 lode mining claims, a contiguous group of 165 claims in the Viola mining district.

The work was conducted on VI # 229-241, VI # 138-145, VI # 203-210 and Peak # 1-10 claims which are contiguous with the rest of the claim block, for the benefit of the entire group of claims. The work was a continuation of and a follow up to work conducted prior to the current assessment year.

Geologic evaluations and sampling of mineralized vein structures and selected favorable host beds were conducted to further evaluate the prior discovery of valuable mineral deposits and to assist in planning additional exploration and development work which includes laying out a drilling program. The geochemical sampling was concentrated along extensions of previously discovered vein structures and specifically favorable host beds. The sampling revealed the presence of anomalous gold and silver and indicator trace elements associated with these structures and beds. Earlier reports are being updated with the results of this work.

Drilling access roads were designed and routes flagged in on site. Minor improvements were made to existing roads.

The work on the property was directed by William W. Walker, a geologist with over 25 years experience and a degree in geology from the Colorado School of Mines. The work was performed during several periods between March 1 and August 31, 1987. The cost of the work was in excess of \$16,500 and was paid for by Canyon Resources Corporation.
