JUDGMENT AND ORDER

This matter came on for hearing before the above entitled Court setting without a jury on the 14th day of September 1987, on the verified Petition of RHONDA LYNN KELLER; Petitioner being personally present in Court and Respondent THOMAS JOEL DEVUONO also personally present; JAMES L. WADSWORTH, District Attorney Lincoln County, present.

The Court having reviewed all the files and records and hearing testimony and accepting evidence from each party and good cause being shown therefore,

FINDS AS FACT

1. That Respondent owes a duty of support to ROBERTA JO (BALLOW) DEVUONO, the minor child of the parties here to;
2. That Respondent is \$2,175.00 in arrears in previously order support, and

Lincoln County

1 3. \$150.00 per month is a reasonable amount for Respon-
2 dent to pay as monthly support and allowance.

3 That from these findings the Court concludes as a matter
4 of Law that Petitioner should have judgment in the amount of
5 arrearages and that the duty of support continue.

6 IT IS THEREFORE ORDERED ADJUDGED AND DECREED, That
7 Judgement be entered on favor of the Petitioner and against
8 Respondent in the amount of \$2,175.00 together with interest at
9 the statutory rate until paid, and it is

10 FURTHER ORDERED that Respondent pay to Petitioner the
11 continuing sum of \$150.00 per month for the suport and main-
12 tenance and of ROBERTA JO (BALLOW) DEVUONO until said child
13 reaches the age of majority or becomes otherwise self supportive
14 or emancipated, and it is

15 FURTHER ORDERED, that the Respondent, having continued in
16 open Court, a wage assignment for the current support be
17 obtainted against Respondent for the current support.

18 The Court maintains jurisdiction to enter a further
19 order on regular payments on the arrearages after consultation
20 between Respondent and District Attorney for the purpose of
21 making recommendation to Court as to such payment.
