The Claim is approximately 1500 feet long and 600 feet wide, such that 1400 feet is claimed in a S 35° E direction and 100 feet in a N 35° W direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the NW to the SE direction.

No. 5: SE Corner	Cor.No.5 (Sec)	4"x4"x4' wooden post with rock cairn
No. 6: Cen. N. Sideline	Cor.No.6 (C.N.Sdln.)	4"x4"x4' wooden post with rock cairn

Markings also include name of the claim and a sketch depicting the claim and adjacent claims. As erected on the ground, each side center or corner monument is marked as described above by metal tags nailed to posts (e.g. metal tags, paint on posts).

The work of location consisted of making a claim map as provided in NRS 517.040.
