2. A Quitclaim Deed from JOHN SANTIAGO to DALLAS MINES NEVADA, INC. transferring all right, title and interest which JOHN SANTIAGO may have in and to the following described property:

"Those certain mill tailings heretofore purchased by Gold Star Investments, Inc. from Dallas Mines Nevada, Inc. pursuant to that certain Agreement of Sale, dated January 9, 1980, such tailings located immediately South of the Caselton Mill in Lincoln County, Nevada and more particularly described in said Agreement of Sale."

This Full Satisfaction of Judgment as to Defendant JOHN SANTIAGO Only releases and discharges JOHN SANTIAGO only from his obligations or liabilities pursuant to the above-mentioned Judgment, and shall not affect or restrict the rights of Plaintiff, DALLAS MINES NEVADA, INC., to pursue collection of the balance of said Judgment against Defendant, Gold Star Investments, Inc. (except that
