TO HAVE AND TO HOLD the same together with the ores, minerals, dips, spurs, angles thereof, extralateral rights, all other and singular rights thereunto pertaining, all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues, profits thereof, all water rights, geothermal resources, petroleum, natural gas, other hydrocarbons, if any, and any and all other minerals and mineral and surface rights to the Grantee and its successors and assigns forever.
